VOTING FOR THE HAURAKI COLLECTIVE RATIFICATION COMMENCES 4 FEBRUARY 2017

The Mandated Treaty negotiators for the 12 Iwi of Hauraki have negotiated a collective redress deed with the Crown and voting is opening on Saturday 4th February 2017 on the deed and associated post-settlement governance entities.

Document packs containing the following information will be posted to all registered adult members.

- ❖ Ratification booklet explaining the Hauraki Collective Redress package and PSGE;
- ❖ Voting pack including a voting paper and voting information; and
- ❖ Freepost envelope for postal vote submissions.

The HAURAKI COLLECTIVE RATIFICATION of the TREATY DEEDS of SETTLEMENT

is now underway. This is a two-step process commencing with the Hauraki Collective ratification this will be followed by our Iwi Ngāti Tara Tokanui ratification which is tentatively due to commence in March 2017.

NGATI TARA TOKANUI RATIFICATION

Following the conclusion of the Hauraki ratification Ngati Tara Tokanui Iwi will be conducting our own Iwi specific ratification process. This means that our iwi will need to vote on whether to accept the proposed Deed of Settlement. **We will inform you when the voting opens.**

The resolution to be voted on is:
